

## JULY 25, 2024 ORDINARY AND EXTRAORDINARY SHAREHOLDERS' MEETING: FILING OF DOCUMENTATION

## <u>Methods of participation in the Ordinary and Extraordinary Shareholders' Meeting - Obligation to</u> <u>grant proxy authorisation to the Appointed Representative</u>

Toscana Aeroporti reminds that shareholders may only participate in the Ordinary and Extraordinary Shareholders' Meeting by granting proxy authorisation to the Designated Representative, identified as Computershare S.p.A. pursuant to Article 135-*undecies* of the Consolidated Law on Finance (TUF), without participation in the proceedings of any other vote-holder or physical presence of any individual shareholders.
